

Information on Jetprime Srl for the processing of personal data

1. Data subject to processing

2. Treatment

At the end of the retention period, the Data will be deleted and deleted from all paper and/or IT media in a secure manner and in full compliance with the time-to-time legislation in force regarding the protection of Personal Data.

6. Subjects authorized to process Data, Communication and Dissemination

- d. third-party companies for the specific sending of advertising communications. These companies (based in the EU, will ensure compliance with EU privacy regulations)

Your Data will not otherwise be disclosed and/or communicated.

7. Rights of the data subject

As an Interested Party, you are entitled to the rights referred to in the GDPR.

Precisely, it is up to you:

- request confirmation of the existence of personal data concerning him (right of access);
- know its origin;
- receive intelligible communication;
- have information about the logic, methods and purposes of the processing;
- request the updating, rectification, integration, deletion, anonymous transformation, blocking of data processed in violation of the law, including those no longer necessary for the pursuit of the purposes for which they were collected, the portability of the data
- in cases of consent-based processing, receive your data provided to the data controller, in structured and readable form by a data processor and in a format commonly used by an electronic device;
- the right to lodge a complaint with the Supervisory Authority which is the GUARANTOR for the Protection of Personal Data
